## RULES & REGULATIONS

**Company Eligibility:** Bona fide businesses are eligible—Federal Tax ID is required on Official Entry Form.

**Player Eligibility:** Amateur players only—No Golf Professionals. Players must be at least 21 years old.

-Players must have at least one-year employment with team company.

-Players competing in the NET COMPETITION must have an established, valid and current USGA approved handicap index—All handicaps must be computed by the GHIN computation service. Anyone without a valid GHIN will automatically be entered into the GROSS COMPETITION.

**Subscription:** Limited to first 18 Gross and 18 Net Teams with paid registration.

-Over-subscription will result in a Priority List, withdrawals being filled from said list.

-Under-subscription may result in cancellation of event and refund of entry & sponsorship fees.

**Tournament Entry & Withdrawal:**

-Entry Fee includes use of range, golf cart, golf & awards banquet for one 2-player team.

-Entry Fees must be paid by check, money order or credit card.

-Withdrawals must be made on or before 9/21/09.

-Refunds are subject to a 10% charge if made within 2 weeks of event.
