Participation may, at the discretion of the Club, be suspended or revoked and all fees or dues forfeited for breach of any Great River Golf Club rules and regulations.

CREDIT AGREEMENT

1. The participant will be furnished with a monthly statement of account. Participants agree to remit payment in full within fifteen (15) days of the billing date. If the payment is received within the fifteen (15) day billing period no finance charges will be applied.
2. Accounts where payments are received after the 15th day will be assessed a \$10.00 late fee. After 30 days 1.5% interest will be assessed. After 45 days membership will be suspended.
3. The participant to whom credit has been granted promises to pay Great River for all credit extended including any applicable finance charges. A valid credit card is required to be on file with Great River for participant on-premise charging privileges.
4. In an effort to ensure membership costs remain as low as possible; Great River recommends membership and member account payments to be made by cash or check. If you elect to pay by credit card, Great River will add a 1.5% service fee to your payment as charged by our credit card companies.
5. If payment in full is not received by the fifteenth (15th) day there will be an automatic credit card charge made on the designated card on account at Great River.
6. In the event said card is denied or cancelled a finance charge is computed by applying a monthly rate of 1.5% on the unpaid balance at the next billing date. The annual percentage rate of 18% is compounded monthly and all finance charges are for interest.
7. In the event a participant is in default of payment, Great River may declare all amounts owing to be immediately due and payable. Great River reserves the right to suspend privileges on any account in default.
8. Participants agree to pay all costs and disbursements, including attorney's fees incurred in the collection of indebtedness to Great River.
9. Applicable state and federal laws shall govern the validity of this agreement.
10. Great River reserves the right to amend this agreement and, in that event, shall notify the participant in writing.

To best utilize your membership, please refer to the following information & club policies.

TEE-TIME RESERVATION

- Members have 14-Day advance reservation privileges
- Members can only book one foursome under their own name 14-days in advance. Members wishing to book more than 4 players in advance can only do so within 7-days in advance. For these bookings, an additional reservation agreement must be signed and returned to the Pro Shop.
- Members booking outside of the normal booking window will be charged a nonrefundable advanced booking fee of \$25 per player.

CANCELLATION POLICY

- 48-Hour notice is required to cancel or change the number of players for your reservation.
- Any reservation not cancelled or changed at least 48-hours in advance will be charged to your membership.
- You are expected to play rain or shine, except in the event Great River management closes the course. Rain checks are only issued to your guests that play less than 12 holes of golf. The Pro Shop will authorize rain checks to those individuals the day of the reservation.

GUEST POLICY

- Each membership provides for up to 4 (four) 20% off discount guest greens fees per month. An individual guest may utilize only one discount guest green fee once each month.

RULES OF PLAY FOR GOLF

- All members are reminded that you must check into the Pro Shop regardless if you are using the practice facility or golf course.
- Unless otherwise posted, USGA rules shall govern all play.
- Players are requested to maintain their position on the course. Great River requires players that cannot keep pace to advance to their proper place on the course.
- At the beginning of your round, the Starter will provide your group with the rules of play for the day.
- Players must abide by instructions from the golf professionals, outing director and all players' assistants.
- All players are required to use proper etiquette while on property. Players are asked to rake their own sand trap, replace and fill divots with sand/soil mix and repair ball marks on greens.
- All players are asked to refrain from hitting multiple shots from one location on the course.
- It is the policy of the Golf Club to require everyone playing to have his or her own golf clubs and bag.

DRIVING RANGE & PRACTICE FACILITY

- The Driving Range and Practice Facility opens approximately 45 minutes before the first tee time every morning except for Mondays and Thursdays. On these days, the opening time will vary according to the time of season. The facility closes one hour before dark every evening throughout the season.
- For the safety of our guests on the golf course, woods are not permitted on days that the driving range is set-up on the front grass tee.

To best utilize your membership, please refer to the following information & club policies.

FOOD & BEVERAGE

- It is the policy of Great River to not allow food or beverage to be brought on property.
- Coolers are only permitted on the golf course to hold prescribed medication or food and beverage specific to treating a diagnosed medical problem. If there is a question regarding this, please address it with management.

CARTS

- Players driving a cart must be at least 18 years old and have a valid driver's license.
- Cart use is limited to two (2) riders per cart.
- Non-playing guests are prohibited.
- Please refer to the starter before your round for the cart rules for the day.
- Carts cannot be driven on any greens, tees, wooded areas or tall grass.
- For your safety, carts are not allowed on the 3rd, 8th, 10th, 13th or 16th fairways.

DAMAGE TO PROPERTY

- Players are liable for any damage that they personally cause to the property. This includes, but is not limited to: severe damage to the turf, structural damage to the clubhouse, damage to golf carts or other property not noted. Great River Golf Club will receive fair estimates to repair any damage and bill all payments to the responsible party.

DRESS CODE

- All shirts must have collars or mock-necks except ladies golf specific collarless shirts
- Shorts for ladies and gentleman must be of Bermuda style and length
- Great River Golf Club is a high-end facility. As such, denim in any form, short shorts, cut-offs, tee shirts, tank tops, spandex, drawstring or athletic sweat suits or swimming attire of any type are not permissible items of clothing that can be worn while on property.
- Proper footwear must be worn on the golf course. Great River Golf Club does not allow players with metal spikes or those wearing shoes with heels of any type on the course at any time.

LIGHTNING

- Our weather alert system warns golfers when severe weather conditions are within five miles. When the alert sounds, all players must cease play and immediately return to the clubhouse. The manager on duty will notify players when they may resume play.

CELL PHONES

- Restricted use of cell phones is permitted on the golf course. Courtesy to other players requires that you silence your cell phone until you have completed play. Play delays related to cell phone use should be avoided.

DISABLED GOLFERS

- Great River Golf Club welcomes golfers of all abilities and will make every effort to make your experience at Great River an enjoyable one.
- Management will provide golfers covered by the ADA with a separate car with an identifying flag. This will allow the disabled golfer only to leave and return to the cart path at designated points on each hole. To be eligible, a valid handicap certificate or signed physician's note must be presented to the Pro Shop at the time of check-in. Please address any questions or concerns to management.
